I. INTRODUCTION

The sale and transfer of this motor vehicle is made on an "AS IS" basis, without any express or implied warranties, with no recourse to the Town, provided that the Town can issue proof that it has title to the property without any liens or encumbrances. The form of payment used must be cash, money order or cashier's check. Sales tax will be included as part of the purchase price.

II. VEHICLE DETAILS



The vehicle runs well and is well-maintained (records included). There is a crack in the frame which prevents it from passing Maryland state inspection. The winning bidder will sign a Vehicle Bill of Sale agreeing to accept the motor vehicle in its existing state.
