COUNTY OF KEWAUNEE
STATE OF WISCONSIN**

**AN ORDINANCE AMENDING SECTION 32-2 OF THE
CODE OF ORDINANCES OF THE CITY OF ALGOMA, WISCONSIN
RELATING TO OFFENSES AGAINST STATE LAW**

WHEREAS: The Common Council of the City of Algoma has the authority to amend the city's municipal code, and

WHEREAS: The Common Council finds that it is necessary to amend portions of the municipal code to coordinate with the TraCS system.

NOW, THEREFORE the Common Council of the City of Algoma does ordain that:


