North Carolina General Statute 162A Article 8 was signed into law July 20, 2017, and requires that all water and sewer system development fees must be adopted by Resolution in accordance with the conditions and limitations of Article 8. Raftelis provided the required study as required by State Law that the Board reviewed and approved it at the June 2020 meeting. As required by N.C. General Statute, the City provided an opportunity for public comment. (Attachment 4B)

Recommended action: Staff recommends the Board adopt the Resolution as required by the General Statue.

5) NEW CITY BUSINESS

A. Consider appointing Wilkinson & Carpenter, P.A., to serve as the legal advisor to the Oxford Planning Board.

Attorney Lori Dutra resigned from the Planning Board at the February meeting to devote more time to the DOEDC.

The City has received interest from representatives of Hicks & Wrenn, PLLC, and Wilkinson & Carpenter, P.A. While both firms are well qualified to serve as a legal advisor to the Planning Board. The Planning Department feels there will be less of a conflict of interest if the Board appoints Wilkinson & Carpenter because Hicks & Wrenn serve most of the rezoning & text amendments that are received.

Recommended action: Staff recommends appointing Wilkinson & Carpenter, P.A. to serve as the legal advisor to the Oxford Planning Board.
