

RESOLUTION # 2023 - 10

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF UVALDE, TEXAS FOR THE PURPOSE OF MAKING CERTAIN IMPROVEMENTS AT GARNER FIELD AIRPORT WITH THE ASSISTANCE OF THE TEXAS DEPARTMENT OF TRANSPORTATION AVIATION DIVISION AND AUTHORIZING TXDOT AVIATION DIVISION TO ACT AS IT'S AGENT

WHEREAS, City of Uvalde intends to make certain improvements to Garner Field Airport; and

WHEREAS, the general description of the project is described as: pavement rehab project to include: chip seal & overlay of runway & parallel taxiway, clean and seal joints & cracks and seal coat airfield pavement (taxiways, taxilanes & aprons), and

WHEREAS, City of Uvalde intends to request financial assistance from the Texas Department of Transportation for these improvements; and

WHEREAS, total project cost are estimated to be \$5,154,600, and the City of Uvalde will be responsible for 10% of the total project costs currently estimated to be \$515,460; and

WHEREAS, City of Uvalde names the Texas Department of Transportation as its agent for the purposes of applying for, receiving and disbursing all funds for these improvements and for the administration of contracts necessary for the implementation of these improvements.

NOW, THEREFORE, BE IT RESOLVED, that City of Uvalde hereby directs the City Manager to execute on behalf of City of Uvalde, at the appropriate time, and with the appropriate authorizations of this governing body, all contracts and agreements with the State of Texas, represented by the Texas Department of Transportation, and such other parties as shall be necessary and appropriate for the implementation of the improvements to Garner Field.


