**Candidates who receive the most votes in a General Election are elected to office.** You may vote for all offices and questions on the ballot for your precinct, regardless of your party affiliation. A General Election must be held throughout the State on the first Tuesday after the first Monday of November in each even-numbered year. (NRS 293.12755)

**NOTE:** Some offices and/or candidates may only appear in the General Election and not the Primary because of requirements in NRS 293.260 and 293.257 or because they are Special District Offices (Moapa Valley and Virgin Valley Water Districts), while others may not appear in any election because not enough candidates filed. Nevada law does not permit write-in candidates.
