The clerk must also keep an official record of the proceedings of every meeting; administer oaths of office; and process, record, file and, when necessary, advertise ordinances, resolutions and the municipal budget. The Municipal Clerk acts as the Chief Administrative Officer of all Elections and the Chief Registrar of Voters. The Clerk is also responsible for any other duties that may be imposed by state statutes and regulations or municipal ordinances or regulations.
