REGULAR ITEMS

PREVIOUS BUSINESS:

- 1) **Ordinance 2021-045** Approving the application for the establishment of the Downtown Lebanon Community Entertainment District

Sponsor: Brewer, Messer, Mathews, Wyatt

Abstract

This ordinance approves the application to establish a Downtown Lebanon Community Entertainment District in an effort to enhance and provide dining, retail, and entertainment opportunities for the City as authorized by the Ohio Revised Code 4301.80.

NEW BUSINESS:

- 1) **Ordinance 2021-049** Authorizing the purchase of road salt from Cargill Inc. Deicing Technology Business Unit

Sponsor: Messer, Mathews, Shope

Abstract

This ordinance authorizes the City Manager to purchase road salt from Cargill Inc. Deicing Technology Business Unit, through the Warren County Engineer's Office Bulk Ice Control Rock Salt purchasing program for \$72.29 per ton for dump delivery and \$86.00 per ton for piler delivery as established in the contract bid.

- 2) **Ordinance 2021-050** Approving the final plat as recommended by the Planning Commission for Countryside Place Subdivision and Declaring an Emergency

Sponsor: Brewer, Messer, Mathews, Shafer, Wyatt

Abstract

This ordinance approves the record plan for the Final Plat of Countryside Place Section 1, combining two parcels into one for the purpose of constructing a multi-tenant retail center on Deerfield Road in front of Rural King.

- 3) **Ordinance 2021-051** Approving the final plat as recommended by the Planning Commission for Sheppard Trail and Declaring an Emergency

Abstract

This ordinance approves the record plan for the final plat of Sheppard Trail Subdivision, combining two small parcels to create a larger single lot for construction of a single family home.

- 4) **Ordinance 2021-052** Authorizing the Mayor to Execute an Employment Agreement with Daniel Burke and Declaring an Emergency

Sponsor: All Members of Council

Abstract

This ordinance establishes an employment agreement between the City of Lebanon and Daniel Burke as the City Auditor.

- 5) **Ordinance 2021-053** Outlawing abortion and declaring Lebanon, Ohio a sanctuary city for the unborn and Declaring an Emergency

Sponsor: Brewer, Messer, Mathews, Monroe, Shafer, Shope

Abstract

This ordinance will outlaw abortion and declare Lebanon a sanctuary city for the unborn as well as making various provisions and findings, providing for severability and establishing an effective date.
