3. Discuss and take action regarding the request of Warren Pena, 1613 Dallas Street, for a ten foot (10') variance, five foot (5') encroachment, to the fifteen foot (15') side yard building setback for construction of a new home.
4. Discuss and take action regarding the request of Dia Abochamh, 701 Lee Avenue, Lot 3, for a three foot (3') variance to the minimum one hundred ten foot (110') lot depth requirement, total of one hundred seven foot (107') lot depth size, for construction of a new home.
