DESCRIPTION OF THE PROGRAM/PROJECT AND BACKGROUND INFORMATION:

Per RCW 35.77, the purpose of the 6-Year Transportation Improvement Program (TIP) is "... to assure that each city and town shall perpetually have available advanced plans looking to the future for not less than six years as a guide in carrying out a coordinated transportation program."

The TIP is used by several state and federal agencies, and serves multiple purposes. It is mainly for local agencies to prioritize their transportation projects anticipated to be done during the next six years; for the Washington State Department of Transportation (WSDOT) to know what projects are anticipated; to list those projects that have federal and/or state funding secured; to identify those projects that are anticipating state or federal funding that is not yet secured; and to allow WSDOT to create a list of projects for the Statewide Transportation Improvement Program (STIP). Federally funded projects must be incorporated into the STIP before money will be disbursed to a local agency. The 6-Year TIP is required to be updated annually and adopted each year. The City is mandated to submit it to WSDOT within 30 days of adoption and preliminary data is due to WSDOT June 30th.

DESCRIPTION OF THE PROGRAM/PROJECT AND BACKGROUND INFORMATION:

In early May, the City of Shelton Public Works Department applied for grant funding to assist with pavement repairs through the Transportation Improvement Board (TIB) Emergency Repair Program. TIB approved funding for a one-time 2017 Emergency Repair Program in recognition of state and local emergency proclamations regarding severe winter weather. The engineering and public works departments worked together to compile and submit photographic evidence of several street sections requiring repair that qualified for the emergency repair program. Thanks to the efforts of the City's engineering and public works departments, Shelton was awarded \$50,000 – the maximum available to any one agency.

The indicated street repairs must be completed by the end of August.

ANALYSIS/OPTIONS/ALTERNATIVES:

The award money must be spent to repair the road sections indicated in the grant application.

THIS GRANT AGREEMENT (hereinafter "Agreement") for the 2017 Emergency Pavement Repair Project, Various Locations (hereinafter "Project") is entered into by the WASHINGTON STATE TRANSPORTATION IMPROVEMENT BOARD (hereinafter "TIB") and CITY OF SHELTON, a political subdivision of the State of Washington (hereinafter "RECIPIENT").

1.0 PURPOSE

TIB hereby grants funds in the amount of \$50,000 for the project specified above, pursuant to terms contained in the RECIPIENT'S TIB-approved Grant Application on file, which is incorporated into this Agreement by this reference; supporting Project Documentation in 3.0; chapter 47.26 RCW; title 479 WAC; and the terms and conditions listed below.

2.0 SCOPE AND BUDGET

The Project Scope and Budget are initially described in RECIPIENT's Grant Application and previously incorporated by reference into this Agreement. Scope and Budget may be further developed and refined. Any alterations to the original Project Scope or Budget as initially described in the Grant Application must be authorized by TIB in advance by written amendment.

3.0 PROJECT DOCUMENTATION

TIB requires RECIPIENT to make reasonable progress and submit timely Project documentation as applicable throughout the Project. Upon RECIPIENT's submission of each Project document to TIB, the terms contained in the document will be incorporated by reference into the Agreement. Required documents include, but are not limited to, the following:

- a) Contract Completion Updated Cost Estimate with final summary of quantities; and
- b) Project Accounting History

4.0 BILLING AND PAYMENT

At the closeout of the Project, but no later than August 31st, 2017, the Recipient must submit an invoice for all costs and expenditures actually incurred in the course of performing eligible work directly related to the Project, during the Project period. Any invoice received after August 31, 2017, will not be eligible for reimbursement, unless the local agency has received prior approval from TIB. TIB agrees to reimburse the Recipient for those Project-related costs and expenditures properly documented on the Recipient's invoice.



5.0 TERM OF AGREEMENT

The term of this Agreement shall commence on the latest date of signature of the Parties and terminate upon closeout of the grant or when terminated as provided herein, but in no event shall the term of this Agreement exceed six months unless amended by the Parties.

6.0 AMENDMENTS

This Agreement may be amended by mutual agreement and written amendment executed by both of the Parties. Such amendments shall not be binding unless they are in writing and signed by persons authorized to bind each of the Parties.

7.0 ASSIGNMENT

The RECIPIENT shall not assign or transfer its rights, benefits, or obligations under this Agreement without the prior written consent of TIB. The RECIPIENT is deemed to consent to assignment of this Agreement by TIB to a successor entity. Such consent shall not constitute a waiver of the RECIPIENT's other rights under this Agreement.

8.0 GOVERNANCE & VENUE

This Agreement shall be construed and interpreted in accordance with the laws of the state of Washington and venue of any action brought hereunder shall be in the Superior Court for Thurston County.

9.0 DEFAULT AND TERMINATION

9.1 NON-COMPLIANCE

- a) In the event TIB determines, in its sole discretion, that the RECIPIENT has failed to comply with the terms and conditions of this Agreement, TIB shall notify the RECIPIENT, in writing, of the non-compliance.
- b) In response to the notice, RECIPIENT shall provide a written response within 10 business days of receipt of TIB's notice of non-compliance, which should include either a detailed plan to correct the non-compliance, a request to amend the Project, or a denial accompanied by supporting details.
- c) TIB will provide 30 days for RECIPIENT to make reasonable progress toward compliance pursuant to its plan to correct or implement its amendment to the Project.
- d) Should RECIPIENT dispute non-compliance, TIB will investigate the dispute and may withhold further payments or prohibit the RECIPIENT from incurring additional reimbursable costs during the investigation.

9.2 DEFAULT

RECIPIENT may be considered in default if TIB determines, in its sole discretion, that:

- a) RECIPIENT is not making reasonable progress toward correction and compliance;
- b) TIB denies the RECIPIENT's request to amend the Project, if any; and
- c) After investigation, TIB confirms RECIPIENT'S non-compliance.

TIB reserves the right to order RECIPIENT to immediately stop work on the Project and TIB may stop Project payments until the requested corrections have been made or the Agreement has been terminated.

9.3 TERMINATION

- a) In the event of default by the RECIPIENT as determined pursuant to Section 9.2, TIB shall serve RECIPIENT with a written notice of termination of this Agreement, which shall be served in person, by email or by certified letter. Upon service of notice of termination, the RECIPIENT shall immediately stop work and/or take such action as may be directed by TIB.
- b) In the event of default and/or termination by either PARTY, the RECIPIENT may be liable for damages as authorized by law including, but not limited to, repayment of grant funds.
- c) The rights and remedies of TIB provided in the AGREEMENT are not exclusive and are in addition to any other rights and remedies provided by law.

9.4 TERMINATION FOR NECESSITY

TIB may, with ten (10) days written notice, terminate this Agreement, in whole or in part, because funds are no longer available for the purpose of meeting TIB's obligations. If this Agreement is so terminated, TIB shall be liable only for payment required under this Agreement for performance rendered or costs incurred prior to the effective date of termination.

10.0 USE OF TIB GRANT FUNDS

TIB grant funds come from Motor Vehicle Fuel Tax revenue. Any use of these funds for anything other than roadway system pavement repair is prohibited and shall subject the RECIPIENT to the terms, conditions and remedies set forth in Section 9.

11.0 INCREASE OR DECREASE IN TIB GRANT FUNDS

At Bid Award and Contract Completion, RECIPIENT may request an increase in the TIB funds for the specific Project. Requests must be made in writing and will be considered by TIB and awarded at the sole discretion of TIB. All requests for such increases must be made pursuant to WAC 479-05-202 and/or WAC 479-01-060. If an increase is denied, the recipient shall be liable for costs incurred in excess of the grant amount. In the event that final costs related to the specific Project are less than the initial grant award, TIB funds will be decreased and/or refunded to TIB in a manner that maintains the original ratio between TIB funds and total project costs.

12.0 INDEPENDENT CAPACITY

The RECIPIENT shall be deemed an independent contractor for all purposes and the employees of the RECIPIENT or any of its contractors, subcontractors, and employees thereof shall not in any manner be deemed employees of TIB.



13.0 INDEMNIFICATION AND HOLD HARMLESS

- a) The RECIPIENT shall indemnify and hold TIB, its agents, employees, and officers harmless from, and process and defend at its own expense, any and all claims, demands, suits at law or equity, actions, penalties, losses, damages, or costs (hereinafter referred to collectively as "claims"), of whatsoever kind or nature brought against TIB and arising out of, in connection with or incident to this AGREEMENT and/or the RECIPIENT's performance or failure to perform any aspect of this AGREEMENT. This indemnity provision applies to all claims against TIB, its agents, employees and officers arising out of, in connection with or incident to the negligent acts or omissions of the RECIPIENT, its agents, employees, officers and subcontractors. Provided, however, that nothing herein shall require the RECIPIENT to indemnify and hold harmless or defend the TIB, its agents, employees or officers to the extent that claims are caused by the negligent acts or omissions of the TIB, its agents, employees or officers; and provided further that if such claims result from the concurrent negligence of (a) the RECIPIENT or its employees, agents, officers or contractors and (b) the STATE, its employees or authorized agents, the indemnity provisions provided herein shall be valid and enforceable only to the extent of the negligence of the PARTY, its employees. officers, authorized agents, and/or contractors. This indemnification and hold harmless provision shall survive termination of this AGREEMENT.
- b) The RECIPIENT specifically assumes potential liability for actions brought by RECIPIENT's employees and/or subcontractors; and, solely for the purposes of this indemnification and defense, the RECIPIENT specifically waives any immunity under the State Industrial Insurance Law, Title 51 Revised Code of Washington.
- c) In the event either the RECIPIENT or TIB incurs attorney's fees, costs or other legal expenses to enforce the provisions of this section of this AGREEMENT against the other PARTY, all such fees, costs and expenses shall be recoverable by the prevailing PARTY.

14.0 DISPUTE RESOLUTION

- a) The PARTIES shall make good faith efforts to quickly and collaboratively resolve any dispute arising under or in connection with this AGREEMENT to avoid additional incurred costs and delays to the project. The dispute resolution process outlined in this Section applies to disputes arising under or in connection with the terms of this AGREEMENT.
- b) Informal Resolution. The PARTIES shall use their best efforts to resolve disputes promptly and at the lowest organizational level.
- c) In the event that the PARTIES are unable to resolve the dispute, the PARTIES shall submit the matter to non-binding mediation facilitated by a mutually agreed-upon mediator. The PARTIES shall share equally in the cost of the mediator.
- d) The PARTIES agree that they shall have no right to seek relief in a court of law until and unless the Dispute Resolution process has been exhausted.
- e) In the event of litigation or other action brought to resolve a dispute or enforce this Agreement, each Party shall be responsible for its own attorneys' fees and costs.



15.0 ENTIRE AGREEMENT

This Agreement, together with the RECIPIENT'S Grant Application, the provisions of chapter 47.26 Revised Code of Washington, the provisions of title 479 Washington Administrative Code, and TIB Policies, constitutes the entire agreement between the PARTIES and supersedes all previous written or oral agreements between the PARTIES.

16.0 RECORDS MAINTENANCE

The RECIPIENT shall maintain books, records, documents, data and other evidence relating to this Agreement and performance of the services described herein, including but not limited to accounting procedures and practices which sufficiently and properly reflect all direct and indirect costs of any nature expended in the performance of this Agreement. RECIPIENT shall retain such records for a period of six years following the date of final payment. At no additional cost, these records, including materials generated under the Agreement shall be subject at all reasonable times to inspection, review or audit by TIB personnel duly authorized by TIB, the Office of the State Auditor, and federal and state officials so authorized by law, regulation or agreement.

If any litigation, claim or audit is started before the expiration of the six (6) year period, the records shall be retained until all litigation, claims, or audit findings involving the records have been resolved.

17.0 AUTHORIZED SIGNATURES

DESCRIPTION OF THE PROGRAM/PROJECT AND BACKGROUND INFORMATION:

The water main extension from Well #3 to Washington State Patrol (WSP) that was installed in 2013 cost \$2,675,000 and was paid for by WSP. This main extension came with a Latecomer's Agreement, which was calculated for parcels that could be served by the installation to repay WSP; this agreement was never finalized. After a lengthy negotiation with WSP, a final Latecomer's Agreement was settled upon, which includes a connection to the main and the disconnection of WSP's existing well. The disconnection of their well fulfills a requirement that qualifies the City of Shelton for \$1,500,000 in loan forgiveness from the construction of the UMVPZ.

ANALYSIS/OPTIONS/ALTERNATIVES:

With this agreement, the City of Shelton agrees to reimburse WSP up to \$50,000 for the construction of the connection to the main, and \$12,000 forgiveness for administering the Latecomer's Agreement due to the City from WSP. The City of Shelton will also credit WSP \$600 per month for 32 months, for a total of \$19,000, in exchange for WSP well disconnection, and in lieu of collection of Latecomer's fees for Tractor Supply and Mason County Public Works.

AGREEMENT FOR UTILITY CONNECTION AND REIMBURSEMENT OF WATER EXTENSION EXPENSES (LATECOMER AGREEMENT)

This Agreement, entered into this	day of	, 2017, between the City
of Shelton, a municipal corporation,	hereinafter referr	ed to as the "City", and Washington State
Patrol, a public agency, hereinafter r	referred to as "WS	SP":

WITNESSETH:

WHEREAS, the City of Shelton owns and operates a public water system for purposes of supplying potable water for residential, commercial, industrial, and other public and private use and is authorized to supply water outside of its city limits; and

WHEREAS, WSP has entered into a, Utility Extension Agreement with the City of Shelton, dated <u>July 26, 2010</u>, to extend the City's water facilities to its property located at 631 West Dayton Airport Road, Shelton, WA, including Mason County Parcels Nos. 420023260010, 420112200010, 420034160010, 420034160020, and 420101000000 (WSP Academy), said facilities hereinafter referred to as "the Extension"; and

WHEREAS, it is in the mutual interest of WSP and the City to facilitate WSP making a connection to the Extension, so that WSP can obtain City water services and the City can maintain eligibility for a loan forgiveness program; and

WHEREAS, the Utility Extension Agreement requires the City to administer a latecomer agreement to collect reimbursements for WSP, of the fair pro rata share of the construction costs of the Extension, from property owners who did not contribute a pro rata share to construction of the Extension, but hereinafter connect to the Extension; and

WHEREAS, the City and WSP desire to provide for the administration of this latecomer agreement pursuant to Chapter 35.91 RCW and to set forth herein the reasonable rules and regulations for administration thereof.

NOW THEREFORE, IT IS HEREBY AGREED BETWEEN THE PARTIES AS FOLLOWS:

- 1. WSP has completed the construction of the Extension pursuant to the terms of the Extension Agreement and has conveyed the Extension to the City.
- 2. The City will reimburse WSP the cost of construction of a water connection between the WSP facility and the Extension (hereinafter "Connection"), in an amount not to exceed fifty thousand dollars (\$50,000). The Parties agree that a Connection shall be established to the City of Shelton's water system. Upon activation of the Connection, WSP shall disconnect well and water system #02993, submit a letter to the Department of Health

stating the WSP has disconnected its well from the facility being served by the Shelton water system, and state the well will no longer be used for domestic purposes. WSP shall meet all Department of Health requirements to place their public water system #02993 as "inactive" in the DOH's database no later than December 31, 2017.

- 3. The City agrees to grant a credit of six hundred dollars (\$600.00) on each month's water billing to WSP starting October 2017 and ending May 2020 of water service in consideration for Latecomer reimbursements which were not collected prior to the execution of this agreement. The City further acknowledges it has authority to grant such credits to water rates.
- 4. For a period of twenty (20) years from the date of recording of this Agreement, the City shall collect from all persons desiring to connect to the Extension, excluding WSP, a fair pro rata share of the costs to construct the Extension.
- 5. An extension of the twenty-year reimbursement period may be made by amendment of this Agreement for a time not to exceed the duration of any moratorium, phasing ordinance, concurrency designation, or other governmental action that prevents making applications for, or the approval of, any new development within the benefit area for a period of six months or more. Upon the extension of the reimbursement period, amendment to this Agreement must specify the duration of the contract extension and must be filed and recorded with the Mason County Auditor by the City. Property owners who are subject to the reimbursement obligation shall be notified by the City of any extension filed under this subsection.
- 6. No person, firm, or corporation shall be granted a permit or be authorized by the City to connect or use the Extension for the time period after which this Agreement is recorded to the end of the reimbursement period, without first paying to the City the amount required to reimburse WSP for the pro rata share of the cost of said construction as set forth in Exhibit "A," and hereinafter referred to as the latecomer fee. All latecomer fees shall be remitted to WSP within sixty (60) days after the receipt thereof. The City shall waive administrative fees related to project closeout due from WSP, in the amount of twelve thousand one hundred eighty-three dollars and twenty-five cents (\$12,183.25).
- 7. Attached hereto as Exhibit "A" and incorporated by this reference is a listing of the costs of construction of the Extension, including all applicable sales taxes together with a listing of the benefit area which represents properties that may connect to or use the Extension. The Benefited area is defined as all properties within the Shelton Springs Road, State Routes 101 and 102 (Dayton-Airport Road) within the UGA which can be connected to the Extension directly or through lateral extensions. The Benefited Area, with parcel numbers of the benefited properties, is depicted on Exhibit "B."

- 8. In addition to the latecomer fee, each property owner in the Benefited Area shall be required to pay all costs and fees applicable for connecting their properties to the Extension, including the costs of designing and constructing the connection, and any other fees established by the Shelton Municipal Code in effect at the time of connection.
- 9. The latecomer fee for each individual parcel was calculated using an estimate of the parcel's acreage and its front footage which was hereafter modified for its zoning/land use designation. Variation in actual acreage or front footage from estimated acreage used in the formula will not change the latecomer fee unless the variance exceeds twenty percent (20%). The calculation of each benefited parcel's latecomer fee has been determined as set forth in Exhibit "B."
- 10. Prior to the City authorizing any new connection to the Extension during the reimbursement period commencing after recording of this Agreement, the City shall collect from the owner/applicant a sum equal to the amount provided in Exhibit "B" as the fair pro rata share due from such owners upon and for the Extension. Subject to subsection 4, such sums shall be remitted to WSP within sixty (60) days of receipt.
- 11. Whenever any connection is made into the Extension without such payment having first been made in accordance with this Agreement, the City may remove or cause to be removed such unauthorized connection and all connecting lines or pipes located in the facility right-of-way and dispose of such material removed without any liability whatsoever.
- 12. The Parties acknowledge that the City did not collect latecomer reimbursements from two property owners (Mason County parcel number 420021000010 and Tractor Supply parcel number 420024400010), both of which established a connection to the Extension prior to the recording of this Agreement. In exchange for the consideration outlined in Sections 2, 3, 6, and 23 of this Agreement, WSP forever releases and discharges any and all claims against the City for not collecting the assessment from these property owners. If the City recovers latecomer assessments from either of the Property Owners referenced in this paragraph, the City shall be entitled to keep that recovery rather than remitting it to WSP.
- 13. To the extent permitted by law, WSP shall defend, indemnify, and hold the City Harmless from any claims arising from any contract or agreement, written or oral, WSP enters into with any Partnering Entities with regard to the distribution, assignment, or sharing of latecomer reimbursements.
- 14. The City and WSP jointly agree to defend any lawsuits attacking the validity of this Agreement.

- 15. The Parties shall bear their own costs and expenses including, without limitation, attorneys' fees and costs related to this Agreement, the latecomer assessments, and the agreements contemplated herein.
- 16. Disputes arising under this Agreement shall be brought in Mason County Superior Court and adjudicated under the laws of the State of Washington.
- 17. No amendment, change, or modification of this Agreement shall be valid unless made in writing and signed by all of the parties hereto.
- 18. The terms of this Agreement shall run with the land and bind subsequent owners of the properties affected.
- 19. This Agreement constitutes the entire understanding and agreement of the parties with respect to its subject matter and any and all prior agreements, understandings, or representations with respect to its subject matter are hereby canceled in their entirety and are of no further force or effect.
- 20. All exhibits attached hereto are incorporated by reference.
- 21. This Agreement may be executed in counterparts, and each set of duly delivered identical counterparts, which includes all signatories, shall be deemed to be one original document.
- 22. For purposes of calculation of all time periods described herein, this Agreement shall become operative upon its being recorded with the Mason County Auditor.
- 23. The City shall record this agreement against each parcel in the Benefitted Area with the Mason County Auditor within thirty (30) days of execution. The City shall pay the costs of recording.
- 24. Any invalidity, in whole or in part, of any of the provisions of this Agreement shall not affect the validity of any other of its provisions.

DESCRIPTION OF THE PROGRAM/PROJECT AND BACKGROUND INFORMATION

Over the last serval months staff has been negotiating with Mason County Garbage to finalize an agreement. The final contract documents have been reviewed by WCIA and the City Attorney. The main points of this agreement consist of:

- 20yr. Contract
- First 10yrs. 2.5% min. and 4.5% max. increase based on CPI
- Second 10yrs. 100% of CPI (no min. or max.)
- Current rates in place through end of 2017
- \$710,000 Payment for City Solid Waste Equipment
- Prepayment of \$1,000,000 Utility Tax

AGREEMENT BETWEEN CITY OF SHELTON AND MASON COUNTY GARBAGE CO., INC. FOR THE COLLECTION AND DISPOSAL OF SOLID WASTE, RECYCLABLES AND YARD WASTE IN THE CITY OF SHELTON

1. Date and Parties.

This Agreement is made by and between the City of Shelton, a municipal corporation, hereinafter referred to as the "City" and Mason County Garbage Co., Inc., a Washington corporation, hereinafter referred to as "Contractor."

2. <u>Purpose</u>.

Pursuant to Chapter 8.08 of the Shelton Municipal Code ("SMC"), the purpose of this Agreement is to provide for the collection and proper disposition of solid waste, recyclables, and yard waste throughout the City. Contractor does hereby agree to provide solid waste, recyclable, and yard waste collection services for the City and its citizens and businesses and arrange for disposal of such solid waste, recyclables, and yard waste upon the terms and conditions set forth herein.

3. Effective Date and Term of Agreement.

- (a) This Agreement shall be effective July 1st, 2017. This Agreement shall expire on June 30, 2037. Additionally, the Term may, upon the mutual written consent of the City and Contractor be extended for a mutually agreed upon term, in order to facilitate changes associated with the implementation of new technology not required by this Agreement, or changes in service level or frequency that improve the efficiencies and levels of service provided herein, or any other improvements desired by the City.
- (b) Upon mutual agreement, this agreement may be extended beyond the term herein to accommodate changes in technology, regulations or unforeseen circumstances that might occur during the contract period. Any amendment to the provisions of this contract must be mutually agreed upon by the City and the Contractor.

4. Consideration and Equipment Purchase.

- (a) Contractor shall prepay to the City utility tax in the amount of One Million and 00/100 Dollars (\$1,000,000.00) on or before the effective date of this Agreement per the terms of Section 10(b).
- (b) Contractor shall pay the City Seven Hundred Ten Thousand and 00/100 Dollars (\$710,000.00) on or before the effective date of this Agreement for the purchase of City owned equipment listed in **Exhibit B**

5. Exclusive Rights to Solid Waste and Recyclables Collection.

(a) Contractor shall have the exclusive right and the obligation to collect all solid waste, and residential curbside recyclables and yard waste within the City limits during the term of this Agreement. The parties agree to cooperate in the enforcement of the provisions of this Agreement and the City's authority to regulate a system for solid waste handling. Contractor's rights under this Agreement may be subject to the rights

of third parties in annexed areas and those rights shall not be abridged by this Agreement.

- (b) The City and Contractor hereby acknowledge, pursuant to <u>Section 5(a)</u> of this Agreement above, the exclusion of collection and transportation of: (i) construction and demolition debris and other drop box and stationary compactor services, and (ii) commercial recycling services from this Agreement
- (c) Contractor may independently enforce the exclusivity provisions of this Agreement against third party violators, including but not limited to seeking injunctive relief, and the City shall use good faith efforts to cooperate in such enforcement actions brought by Contractor; provided, however, the City shall have no obligation to join or initiate litigation to protect the rights of Contractor (but it must take all reasonable actions to enforce its ordinances).
- Waste or any other hazardous materials that are either restricted from disposal or would pose a danger to collection crews. If materials are rejected for this reason, the Contractor shall leave a written notice with the rejected materials listing why they were not collected and providing the customer with a contact for further information about proper disposal options. The Customer shall remain responsible for all costs associated with handling and disposal of all Hazardous Waste, Special Waste or any other hazardous materials not collected by Contractor. In addition, the Customer shall remain responsible for all costs associated with handling and disposal of all Hazardous Waste, Special Waste or any other hazardous materials inadvertently collected by Contractor. Title to and liability for any Hazardous Waste, Special Waste and any other hazardous materials shall remain with the Customer, even if Contractor inadvertently collects and disposes of such Hazardous Waste, Special Waste and/or other hazardous materials.

6. <u>Future Annexations of Territory by the City</u>.

If, during the Term, additional territory is added to the City through annexation or other means ("Annexed Areas") within which Contractor or its affiliate has an existing WUTC certificate or other franchise for solid waste collection at the time of annexation, Contractor shall make collection in such annexed area in accordance with the provision of this Agreement at the prices set forth in this Agreement upon written notice by the City.

This Agreement shall extend to the Annexed Areas in lieu of a franchise as provided in RCW 35A.14.900 for such Annexed Areas. Contractor agrees that its certificate applicable to those Annexed Areas shall be cancelled effective the date of annexation by the City. Contractor expressly waives and releases its right to claim any damages or compensation from the City, its officers, agents, or assigns arising out of the cancellation of any pre-existing permit or franchise held by the Contractor prior to annexation, and further specifically waives the right to receive any additional compensation or any rights of collection in the newly annexed territory beyond what is provided herein.

The term during which Contractor shall service any Annexed Areas shall be for the term of this Agreement. Should this Agreement expire or be cancelled prior to the

completion of ten years from the effective date of any newly-Annexed Area, as applicable, that area shall revert to the authorized certificated solid waste collection company pursuant to WAC 480-70-141(5) upon approval of the reversion by the Washington Utilities and Transportation Commission, and service under WUTC jurisdiction shall continue for the balance of such ten year period affected by the expiration or cancellation of this Agreement.

Customers in the Annexed Areas shall receive the same containers as used elsewhere in the City, in accordance with the provisions of this Agreement. In the event where an Annexed Area is being serviced with containers different from the City's program, Contractor shall be responsible for timely Customer notification and removal of existing containers and delivery of appropriate containers to those Customers.

7. <u>Definitions</u>.

The meaning to be given words as used herein shall be their normal definition, except as to those words specifically defined in the Shelton Municipal Code or as set forth below:

- (a) The term "aluminum" shall mean cans and containers composed solely of aluminum.
- (b) The term "cardboard" shall mean moderately thick paperboard not contaminated by glue, food, waxed coating or other similar contaminants
- (c) The term "Cart" shall mean a Contractor-provided receptacle which is made of durable, corrosion-resistant, non-absorbent material with a close-fitting cover and wheels. For the collection and storage of solid waste, Contractor shall provide the following sizes of Carts: thirty-two/thirty-five (32-35) gallon, sixty-four/sixty-five (64-65) gallon, and ninety-five/ninety-six (95-96) gallon.
- (d) The term "commercial wood waste" shall mean natural wood or wood biproducts including, but not limited to, pallets, stumps, and shavings, which are not treated with chemicals, paint or other contaminants.
- (e) The term "curbside" shall mean at the curb or up to five (5) feet from the edge of the public road.
- (f) The term "Customer" shall mean all users of services provided by Contractor pursuant to this Agreement, including, without limitation, residents, businesses, property owners, managers and tenants.
- (g) The term "Drive-in" shall mean the charge for leaving the public road to provide service. There shall be no obstruction from overhanging branches and/or wires and adequate room for the collection vehicle to turn around. If the Customer requests drive-in service, the road surface shall be of such material as to withstand the weight of the collection vehicle; all maintenance and repairs shall be the Customers responsibility.
 - (h) The term "Hazardous Waste" shall mean any substance that is:

- (1) Defined as hazardous by 40 C.F.R. Part 261 and regulated as Hazardous Waste by the United States Environmental Protection Agency under Subtitle C of the Resource Conservation and Recovery Act ("RCRA") of 1976, 42 U.S.C. § 6901 et seq., as amended by the Hazardous and Solid Waste Amendments ("HSWA") of 1984; the Toxic Substances Control Act, 15 U.S.C. § 2601 et seq.; or any other federal statute or regulation governing the treatment, storage, handling or disposal of waste imposing special handling or disposal requirements similar to those required by Subtitle C of RCRA.
- (2) Defined as dangerous or extremely hazardous by Chapter 173-303 WAC and regulated as dangerous waste or extremely Hazardous Waste by the Washington State Department of Ecology under the State Hazardous Waste Management Act, Chapter 70.105 RCW, or any other Washington State statute or regulation governing the treatment, storage, handling or disposal of wastes and imposing special handling requirements similar to those required by Chapter 70.105 RCW.
- (i) The term "metal containers" shall mean cans and containers composed of metals, such as tin or steel cans, which are attracted by a magnet.
- (j) The term "mixed paper" shall mean paper (except newspaper), including magazines, mail, phone books, photocopy or printer paper, and envelopes that are not contaminated by food, plastic wrap or other contaminates.
- (k) The term "newspaper" shall mean any part of the newspaper that was included when it was delivered or purchased.
- (I) The term "walk-in" shall mean the charge for carryout of over five (5) feet from the edge of the public road, but not over fifty (50) feet.
- (m) The term "plastic" shall mean plastic water and pop bottles, milk jugs and other plastic bottles with necks smaller than its body.
- (n) The term "recyclables" shall mean those recyclable items defined in RCW 70.95.030(14) designated by the City to be picked up in the curbside recycling program which items are limited to: aluminum, metal containers, mixed paper, cardboard and newspaper, plastic, and glass.
- (o) The term "Special Waste" shall mean polychlorinated biphenyl ("PCB") wastes, industrial process wastes, asbestos containing materials, petroleum contaminated soils, treated/de-characterized wastes, incinerator ash, medical wastes, demolition debris and other materials requiring special handling in accordance with applicable federal, state, county or local laws or regulations.
- (p) The term "yard waste" shall mean any material which occurs naturally and is grown on residential, commercial or industrial property or is included in the landscaping of such property. Food waste or food scraps are not considered yard waste.

8. Rates.

- (a) <u>Initial Rates</u>. All City Customers shall pay Contractor the rates set forth on <u>Exhibit A</u> attached hereto and incorporated herein by reference, along with any applicable City franchise fees and/or other municipal fees or taxes, if any, as are now or later established by the City. Contractor will also assess the Washington Refuse Collection Tax on all solid waste services on a monthly basis and remit such state excise tax amounts to the State. The initial rates for Contractor's services as set forth in <u>Exhibit A</u> shall remain the same until January 1, 2018.
- (b) Annual CPI Adjustment. Beginning January 1, 2018, and for every year thereafter, the rates set forth in **Exhibit A** shall be adjusted by the change in the Consumer Price Index as maintained by U.S. Department of Labor, "Seattle-Tacoma-Bremerton Average" for all Urban Consumers or Successors Index, (excluding any CPI adjustment to the City utility tax and/or other municipal fee or tax amounts in **Exhibit A**), for the period October to October of the previous year. Contractor shall provide the City with notice of any proposed rate increase, in any event, not less than thirty (30) days prior to the requested effective date of the proposed rate adjustment. **Exhibit A** will subsequently be amended to reflect those revised rates. During the initial ten (10) years of the Agreement from July 1, 2017 through June 30, 2027, the CPI adjustment shall be no less than two and one half percent (2.50%) and no more than four and one half percent (4.50%). After the initial ten (10) years of the Agreement, neither the two and one half percent (2.50%) minimum, nor the four and one half percent (4.50%) maximum shall apply.
- (c) <u>Tipping Fees</u>. During the Term, in addition to the CPI adjustments defined in Section 7(b), Contractor is authorized to pass through to its Customers all increases in landfill/disposal costs which are charged by the Mason County Eells Hill Municipal Transfer Station, or any future landfill/disposal facility, and/or increased costs associated with higher solid waste/recycling duties imposed by local, state or federal laws and regulations. Contractor shall also pass through any decreases in tipping fees. The Tipping Fee adjustment shall be calculated after the Annual CPI Adjustment calculation defined in Section 7(b).
- (d) <u>Notice of Rate Increases/Decreases</u>. Contractor shall provide the City with notice of any such proposed rate increase or decrease upon Contractor being notified of an increase or decrease, but in any event not less than thirty (30) days prior to the effective date of such increase or decrease.
- (e) <u>Rate Increases/Unforeseen Costs</u>. Contractor may apply to the City for rate adjustments to reflect unforeseen costs arising during the Term, including, without limitation, fuel increases, tax charges, governmental fees and surcharges and changes in laws, rules and regulations.

Changes in federal, state or local laws or regulations or a continuing Force Majeure event that results in a change in circumstances or hardship for Contractor in performing this Agreement may be the subject of a request by Contractor for a rate adjustment, subject to review and approval by the City, which shall not be unreasonably withheld.

9. <u>Billing and Customer Service</u>.

- (a) All billing for solid waste collection and recycling services within the City limits shall be performed by Contractor on a monthly basis in arrears in accordance with the rates established in this Agreement. Notwithstanding the foregoing, Contractor may elect, in its sole discretion on at least sixty (60) days' prior written notice to all City Customers, to bill City Customers every other month, as opposed to monthly billings.
- (b) The charge for any special services not covered in **Exhibit A** will be determined by mutual agreement of the parties hereto.
- (c) The types of services for which the Customer is being charged will be clearly stated on the face of the bill provided by Contractor. The bill will include a breakdown of charges for each type of service and applicable taxes. Upon request, Contractor shall facilitate the creation of duplicate bills, to be issued to landlord or homeowner.
- (d) The bills provided by Contractor shall be due in accordance with guidelines established by Contractor. If a bill remains unpaid after thirty (30) calendar days from the bill date, a late notice shall be mailed to the Customer and shall include a 1.5% penalty (minimum \$1.00). If the past due balances remains unpaid after forty-five (45) calendar days Contractor shall send a service cancellation notice with a ten (10) calendar day grace period to the Customer. If full payment has not been received by the end of business on the 10th day, service will be terminated. City shall enforce mandatory service including discontinuation of water service as defined in City of Shelton Ordinance 8.08.
- (e) A fee outlined in **Exhibit A** will apply to all Customers stopped for non-payment to re-establish service, plus applicable taxes, if any.
- (f) A fee outlined in **Exhibit A** will be assessed on all checks returned by a financial institution for insufficient funds plus applicable taxes, if any.
- (g) A fee outlined in <u>Exhibit A</u> shall be assessed for redelivery of carts/receptacles where the Customer had requested suspension or termination of service or where the service was suspended for non-payment by Customer.
- (h) Customers whose service is terminated and restarted within one year after the termination of their prior service shall be assessed a service restart fee in accordance with **Exhibit A**. Upon restart of service, Customers shall have the choice of paying a Receptacle redelivery fee in accordance with **Exhibit A** or Customers may pick up their Receptacle(s) directly from Contractor at no charge.
- (i) A fee outlined in <u>Exhibit A</u> will apply to commercial or multi-family accounts requiring special administrative services beyond regular invoicing, such as waste trend reports, disposal ticket proof, receipt of service slips, 3rd-party website data upload, or customized billing terms which conflict with the terms of this Agreement.
- (j) All costs related to billing and bill collection incurred by Contractor will be paid by Contractor.

10. <u>City Utility Taxes.</u>

- (a) <u>City Utility Tax</u>. Contractor shall remit to the City on a monthly (or bimonthly depending on Contractor's then current billing practice) basis the City's applicable utility tax. The amount shall be based on the preceding month's (or two months, as the case may be) Customer invoices, excluding drop box charges and commercial recycling charges, and excluding any bad debt reduction, and excluding any embedded or line-item taxes or fees. Contractor shall embed twenty-six percent (26%) of the current thirty-one percent (31%) City utility tax within the rates in <u>Exhibit A.</u> Contractor shall bill customer five percent (5%) of the current thirty-one percent (31%) as a separate line item within the customer invoice. Should the City modify the utility tax rate, Contractor shall be allowed to recover such change by adjusting rates charged to Customer in <u>Exhibit A</u>. Should the City modify the utility tax rate, Contractor will implement the change within sixty (60) calendar days.
- (b) <u>City Utility Tax Prepayment</u>. Per Section 4(a) of this Agreement, Contractor shall make a one-time prepayment to City in the amount of One Million and 00/100 Dollars (\$1,000,000.00) on or before the effective date of this Agreement. This prepayment shall represent an early payment of the twenty-six percent (26%) of the City utility tax embedded in the rates in <u>Exhibit A.</u> Contractor shall be entitled to the twenty-six percent (26%) of the City Utility Tax embedded in its rates to satisfy the One Million and 00/100 Dollars (\$1,000,000.00) prepayment. Once the prepayment has been fully recouped by Contractor, Contractor shall resume remitting the entire City utility tax to the City per Section 10(a). Contractor shall not withhold the five percent (5%) City utility tax or count this amount against the One Million and 00/100 Dollar (\$1,000,000) prepayment balance.

11. Residential Carts and Containers.

(a) For residential, single dwelling(s), duplex(s), triplex(s) and four-plex(s), Contractor shall provide the following carts and containers:

Recycle (as chosen by the customer):

- Ninety-five (95) or ninety-six (96) gallon recycle carts
- Sixty-four (64) or sixty-five (65) gallon recycle carts
- Thirty-two (32) or thirty-five (35) gallon recycle carts

Yard Waste:

- Ninety-five (95) or ninety-six (96) gallon yard waste carts

Solid Waste:

- Ninety-five (95) or ninety-six (96) gallon garbage carts
- Sixty-four (64) or sixty-five (65) gallon garbage carts
- Thirty-two (32) or thirty-five (35) gallon garbage carts

The carts shall be provided, maintained and/or replaced by Contractor at Contractor's expense and shall remain the property of Contractor unless lost or damaged by the customer. A fee outlined in **Exhibit A** will be charged for lost or damaged carts

- (d) Upon mutual agreement, on terms, conditions and rates satisfactory to the parties, the City and Contractor may include additional items for recycling under this Agreement.
- (b) Upon mutual agreement, the City and Contractor may change the method of residential and multi-family recycle collection including but not limited to container size, container quantity and collection frequency. Contractor may, at it's own discretion, change collection method to one glass only cart or container and one fiber and container only cart.

12. Preparation of Recyclables and Yard Waste.

All recycling material and yard waste must be tendered for collection free of contaminants. If any recyclables contain contaminants, such as solid waste, Contractor shall have no obligation to collect such materials. In the event that some recyclables are not collectible, Contractor shall give the Customer notice in writing of the reason so that the problem can be corrected. The following categories of recyclables shall be readied by Customers as follows:

- (a) <u>Aluminum and Metal Containers</u> All containers should be rinsed out.
- (b) <u>Cardboard</u> All cardboard must be flattened and placed inside the cart.
- (c) <u>Mixed Paper and Newspaper</u> Material shall be placed in cart loose (not in plastic bags) and be clean, dry and free of food, plastic wrap and other contamination.
- (d) <u>Plastic</u> Plastic Containers must have lids removed and must be rinsed out.
- (e) <u>Glass</u> Glass Bottles and jars must have lids removed and must be rinsed out.
- (f) Yard waste must be placed into the ninety-five (95) or ninety-six (96) gallon cart furnished by Contractor. Branches shall be no larger than four (4) inches in diameter and shall not exceed the length of four (4) feet. In addition, branches must fit in the yard waste cart with the lid closed. Customers who are signed up for the yard waste program and who wish to put out more yard waste than the cart can hold, may set out additional material in Kraft or other approved compostable bags at the rate set forth in **Exhibit A**.
- (g) Contractor shall provide customers with written materials describing all requirements for recycling and yard waste contents and pick-up.

Upon mutual agreement, on terms, conditions and rates satisfactory to the parties, the City and Contractor may include additional items for recycling under this Agreement.

13. <u>Collection Related Services</u>.

- (a) Contractor becomes the owner of the recyclable materials, including yard waste following collection and can market them in any manner Contractor deems to be economically feasible.
- (b) <u>Weight Restrictions</u>. Contractor is responsible for collection of all containers which do not exceed the weight limits, described below:

32/35 gallon Cart 45 lbs

64/65 gallon Cart 90 lbs

95/96 gallon Cart 135 lbs

If a container exceeds these weight limits, Contractor may refuse service and will tag the overweight container.

14. <u>Breach of Contract</u>.

- (a) Breach by Contractor. Contractor shall be in breach of this Agreement if it violates any material provision of this Agreement. In addition, the following shall be deemed a breach by Contractor:
- (1) Contractor fails to commence the collection of solid waste, recyclables or yard waste, or fails to provide any portion of service for a period of more than five (5) consecutive days at any time during the term of this Agreement.
- (2) Contractor fails to obtain and maintain any permit required by the City, County, or any federal, state or other regulatory body in order to collect materials under this Agreement.
- (3) Contractor's noncompliance creates a hazard to public health or safety.
- (4) Contractor fails to maintain, in good standing, surety and insurance required by this Agreement.
- (b) Breach by the City. The City shall be in breach of this Agreement if it violates any material provision of this Agreement.
- (c) Should a party (the "non-breaching party") at any time, contend that the other party (the "breaching party") has breached any material provision of this Agreement, the non-breaching party shall immediately notify the breaching party in writing of the non-breaching party's contention. The breaching party shall have a reasonable time to cure any such alleged breach, which in all events shall not be less than thirty (30) calendar days, or any such longer period as reasonably needed to cure said breach, provided Contractor initiated curing the breach within such thirty (30) calendar day period, and continues to diligently pursue such breach. If breaching party fails to cure the breach within such time, the non-breaching party may terminate this Agreement.

(b) Provided that the requirements of this Section are met, Contractor shall not be deemed to be in default and shall not be liable for failure to perform under this Agreement if Contractor's performance is prevented or delayed by acts of terrorism, acts of God including landslides, lightning, forest fires, storms, floods, freezing and earthquakes, civil disturbances, wars, blockades, public riots, explosions, unavailability of required materials or disposal restrictions, governmental restraint, labor disputes or strikes, or any other causes, whether of the kind enumerated herein or otherwise, that are not reasonably within the control of Contractor ("Force Majeure"). If as a result of a Force Majeure event, Contractor is unable wholly or partially to meet its obligations under this Agreement, it shall promptly give the City written notice of the Force Majeure event, describing it in reasonable detail. Contractor's obligations under this Agreement shall be suspended, but only with respect to the particular component of obligations affected by the Force Majeure event and only for the period during which the Force Majeure event exists.

15. <u>Defense, Hold Harmless, Indemnification</u>.

(a) Contractor shall indemnify, hold harmless, and defend the City, its elected officials, officers, employees, agents, and representatives from and against any and all claims, actions, suits, liabilities, losses, costs, expenses, and damages of any nature whatsoever, including reasonable costs and attorneys' fees in defense thereof, or injuries, sickness, or death to persons, or damage to property, to the extent caused by Contractor's acts or omissions in the exercise of its duties, rights, and privileges granted by this Agreement. Notwithstanding anything to the contrary contained herein, Contractor shall have no obligation to indemnify the City or the City's elected officials, officers, employees, agents, or representatives, to the extent any such claims, actions, suits, liabilities, losses, costs, expenses, injuries, or damages arise out of: (i) the negligence or willful misconduct of the City or the City's elected officials, officers, employees, agents, or representatives, (ii) the City's breach of any of the terms, conditions, representations, or warranties contained in this Agreement, or (iii) the violation of any law, rule, regulation, ordinance, order, permit, or license by the City or the City's elected officials, officers, employees, agents, or representatives.

The City shall notify Contractor in writing of the assertion of any claim against it for which it is entitled to be indemnified hereunder, and shall give Contractor the opportunity to defend such claim (including the sole right to select and retain counsel of its own choice to represent it in connection with such claim), and shall not settle the claim without the written approval of Contractor (and if Contractor elects to defend such claim, Contractor shall have the sole and exclusive right to resolve and settle such claim, so long as the City has been absolved of any and all liability).

The obligations contained in this Section shall survive expiration or termination of the Agreement.

(b) The City shall indemnify and hold the Contractor, its officers, directors, representatives, agents, subcontractors, and employees harmless from and against any and all claims, injuries, damages, losses or suits including reasonable attorneys' fees and costs, to the extent arising out of the negligent acts or omissions, or the willful

misconduct of the City or its officials, employees, officers, or representatives.

16. <u>Pavement Damage</u>. Except in the case of driver/operator negligence or when being operated in violation of applicable weight limitations, Contractor shall not be liable to the City for damage to pavement, curbing, or driving surface owned or controlled by the City resulting from Contractor's trucks providing services in the agreed-upon area.

17. Liability Insurance.

- (a) Contractor shall procure and maintain, for the duration of this Agreement, insurance against claims for injuries to persons or damage to property that may arise from or in connection with the performance of the services provided under this Agreement hereunder by Contractor, its agents, representatives, employees or subcontractors. The cost of such insurance shall be paid by Contractor. Failure to make insurance payments and to keep policies current shall be cause for contract default.
- (b) <u>No Limitation</u>. Contractor's maintenance of insurance as required by the agreement shall not be construed to limit the liability of Contractor to the coverage provided by such insurance, or otherwise limit the City's recourse to any remedy available at law or in equity.
- (c) <u>Minimum Scope of Insurance</u>. Contractor shall obtain insurance that meets the following of the types described below:
- (1) Automobile Liability insurance covering all owned, non-owned, hired and leased vehicles. The policy shall be endorsed to provide contractual liability coverage. The City shall be named as an additional insured under the Contractor's Automobile Liability insurance policy with respect to the work performed for the City.
- (2) Commercial General Liability insurance shall cover liability arising from premises, operations, independent contractors, products-completed operations, personal injury and advertising injury, and liability assumed under an insured contract. The City shall be named as an additional insured under the Contractor's Commercial General Liability insurance policy with respect to the work performed for the City.
- (3) Workers' Compensation coverage as required by the Industrial Insurance laws of the State of Washington.
- (4) Hazardous Waste Hauling. To the Automobile Liability Minimum Scope of Insurance, add Pollution Liability coverage at least as broad as that provided under ISO Pollution Liability-Broadened Coverage for Covered Autos Endorsement CA 99 48 and the Motor Carrier Act Endorsement (MCS 90) shall be attached.
- (d) Minimum Amounts of Insurance. Contractor shall maintain the following insurance limits:
- (1) Automobile Liability insurance with a minimum combined single limit for bodily injury and property damage of \$1,000,000 per accident.

- (2) Commercial General Liability insurance shall be written with limits no less than \$1,000,000 each occurrence, \$2,000,000 general aggregate and a \$2,000,000 products-completed operations aggregate limit.
- (3) Workers' Compensation coverage as required by the Industrial Insurance laws of the State of Washington.
- (f) Other Insurance Provisions The insurance policies are to contain, or be endorsed to contain, the following provisions for Automobile Liability, Commercial General Liability, and Contractor's Pollution Liability coverage:
- (1) To the extent of Contractor's indemnification obligations hereunder, Contractor's insurance coverage shall be the primary insurance with respect to the City, its officials, employees and volunteers. To the extent of Contractor's indemnification obligations hereunder, any Insurance, self-insurance, or insurance pool coverage maintained by the City shall be in excess of Contractor's insurance and shall not contribute with it.
- (2) Coverage shall state that Contractor's insurance shall apply separately to each insured against whom claim is made or suit is brought, except with respect to the limits of the insurer's liability.
- (g) Acceptability of Insurers Insurance is to be placed with insurers with a current A.M. Best rating of not less than A: VIII. Contractor shall furnish the City with standard ACORD certificates of insurance.

18. Compliance with Laws.

Contractor agrees and covenants to comply with all provisions of Federal, State, County and City laws and ordinances affecting, directly or indirectly, the subject matter of this Agreement.

19. Business Licenses.

Contractor shall obtain, at its own expense, all permits and licenses required by the City or any other governmental authority and maintain the same in full force and effect during the terms of this Agreement.

20. Contractor's Office.

Contractor shall be required to maintain an office provided with telephones and such attendants as may be necessary to take care of requests, orders for special service or instruction from the City. This office shall be in operation between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday, except holidays.

21. Service to New Customers.

Contractor shall provide service to new Customers within seven calendar days after a receipt of a request for service. In the case of container size, if Contractor is unable to provide the size of container ordered by the Customer within seven calendar days, then Contractor may temporarily provide the Customer with any size container; provided,

however, the service provided to the Customer and the rate charged shall be equivalent to the service and rate for the container ordered.

22. Collection.

- (a) <u>Pick-up</u>. Contractor shall make collections of solid waste one time every other week per Customer. Residential pickup shall be made Monday through Friday after 6:00 a.m., and before 6:30 p.m. on a regularly scheduled day of the week. Commercial establishments may be serviced more than once per week when requested, but not more than three (3) times per week. Billing will be based on the number of pickups.
- (b) <u>Holidays</u>. Contractor shall observe Christmas Day as the only holiday in each year of this Agreement, on which no pick-ups shall occur. Service that normally would have been provided on Christmas Day will be provided on the first business day following each respective holiday with resulting delay of one day for the balance of the calendar week.
- (c) <u>Missed pick-ups</u>. Adequate provisions shall be made by Contractor to provide special collections when solid waste or recyclables have not been collected during the regularly scheduled trip as a result of Contractor's inadvertence or neglect in picking up the same. Special pickups for such missed collections shall be made by Contractor when requested by the Customer at no additional cost to the Customer.
- (d) When weather conditions are such that continued operation would result in danger to Contractor's staff, area residents or property, Contractor shall collect only in areas that do not pose a danger. Contractor shall collect solid waste, Recyclables and Yard Waste from Customers with interrupted service on their next regular collection day. When service is resumed, Contractor shall collect reasonably accumulated excess volumes of materials equal to what would have been collected on the missed collection day from Customers at no extra charge. Weather policies shall be included in program information provided to customers by Contractor.
- (e) The City reserves the right to construct any improvement or to permit any such construction in any street or alley in such manner as the City may direct, which may have the effect for a time of preventing Contractor from traveling the accustomed route or routes for collection. However, Contractor shall, by the most expedient manner, continue to collect to the same extent as though no interference existed upon the streets or alleys normally traversed. This shall be done at no extra expense to the City or Contractor's Customers.
- (f) Contractor's employees shall at all times be courteous, refrain from loud, inappropriate or obscene language, exercise due care, perform their work without delay, minimize noise, and avoid damage to public or private property. If on private property, employees shall follow the regular pedestrian walkways and paths, returning to the street after replacing empty containers. Employees shall not trespass or loiter, cross flower beds, hedges or property of adjoin premises, or meddle with property that does not concern them or their task at hand. While performing work under this Agreement, employees shall wear a professional and presentable uniform with an identifying patch and company emblem visible to the average observer. If any person employed by

Contractor to perform collection services is, in the opinion of the City, disorderly or otherwise unsatisfactory, the City shall promptly document the disorderly or unsatisfactory conduct in writing and transmit the documentation to Contractor with a demand that such conduct be corrected. Contractor shall investigate any written complaint from the City regarding any unsatisfactory performance by any of its workers.

23. <u>Equipment</u>.

- (a) Contractor shall furnish all vehicles which shall be specifically designed for collection and hauling of solid waste, recycling and yard waste. Each vehicle shall have a tight metal body design so as to prevent the scattering of solid waste when driven over the streets and highways. The customer service telephone number shall be labeled on the side of the vehicle.
- (b) Contractor shall furnish solid waste collection containers for one and one half (1.5) yard or larger containers as requested by the Customer so long as the equipment requested can be safely and efficiently serviced.
- (c) Contractor shall furnish recycling and yard waste carts to all residential accounts requesting recycling and yard waste services.

24. Maintenance

- (a) Collection vehicles shall be kept in good repair, appearance and sanitary condition at all times. Each vehicle shall have Contractor's name and phone number and an identifying number clearly visible on the truck. Contractor shall not use a firm name containing the words "Shelton", "City" or any other words implying municipal ownership.
- (b) Any equipment found not to comply with the above standards shall be taken out of service and brought to standards before being placed back into service for the City.

25. Mandatory Participation by Citizens/City's Obligation to Enforce

- (a) The City shall maintain in full force and effect an ordinance requiring all residential, multi-family and commercial establishments within the City to utilize Contractor's solid waste collection service.
- (b) Commercial businesses shall have a minimum of weekly solid waste service. Residential customers shall have a minimum of every-other-week service.

26. Reporting Records.

- (a) Reporting. Contractor shall furnish to the City annual reports within sixty (60) calendar days of the end of each year showing the number of tons of solid waste, recyclables and yard waste transported by Contractor to the disposal or processing site during the previous twelve (12) months.
- (b) <u>Disposal Receipts</u>. Contractor shall keep records of solid waste collected and charges therefore. Copies of dump receipts, recyclable receipts and yard waste

receipts shall be maintained by Contractor and provided to the City upon request. The original receipts, or digital copies, shall remain in Contractor's office as part of its records for three (3) years after the termination of any agreement between the City and Contractor.

(c) <u>Schedules and Routes</u>. Contractor shall, at all times, maintain current documentation of schedules and routes for the areas served pursuant to this Agreement, and shall make available for City review current copies of such schedules and routes.

27. Customer Service and Communications.

- (a) <u>Customer Service Staffing</u>. During business hours, Contractor shall maintain sufficient staff to promptly answer and handle complaints and service requests from its service area.
- (b) <u>Service Recipient Complaints and Requests</u>. Contractor shall record all complaints and service requests, regardless of how received, including date, time, Customer's name and address, if the Customer is willing to give this information, method of transmittal, and nature, date and manner of resolution of the complaint or service request in a computerized daily log. Contractor shall make a conscientious effort to resolve all complaints within twenty-four (24) hours of the original call or e-mail, and service requests within the times established throughout this Agreement for various service requests.
- (c) <u>Contractor Website.</u> Contractor shall provide a customer-friendly internet website accessible twenty-four (24) hours a day, seven (7) days a week, containing information specific to the City's collection programs, including at a minimum contact information, material preparation requirements, available services and options, inclement weather service changes and other relevant service information for its Customers. The website shall include an email function for Customer communication with Contractor, and the ability for Customers to submit service requests on-line. E-mailed Customer service requests shall be answered within twenty-four (24) hours of receipt. The website shall offer Customers the option to pay their service bills on-line through a secured bill payment system. Contractor shall update the website as necessary, and provide links to the City's website.

28. Severability.

Should any term, provision, condition or other portion of this Agreement or its application be held to be inoperative, invalid or unenforceable, and the remainder of this Agreement still fulfill its purposes, the balance of this Agreement or its application or other circumstances shall not be affected thereby and shall continue in full force and effect.

29. Notices.

Any Notice required or permitted to be given under this Agreement shall be deemed sufficient if given in writing and deposited into any post office as first-class, postage prepaid, certified mail, return receipt requested, and addressed to Mason County

Garbage, Inc., to the attention of District Manager at P.O. Box 787, Shelton, Washington, 98584, with a copy to Waste Connections, Inc., Attn: Legal Department, 3 Waterway Square Place, Suite 110, The Woodlands, Texas 77380, and to the City to the attention of the City Manager, 525 West Cota Street, Shelton, Washington, 98584. Either party shall give written notice of change of address.

30. Debarment.

Contractor certifies that it is neither excluded nor disqualified as defined in 2 CFR Part 180. Contractor shall refrain from becoming excluded or disqualified, and shall fully comply with the requirements of Subpart C of 2 CFR Part 180 and any applicable parts of 2 CFR Parts 300 through 5899. Contractor shall require each person or entity with whom Contractor enters into a covered transaction at the next lowest tier, as defined in 2 CFR Part 180, to fully comply with the requirements of Subpart C of 2 CFR Part 180, and any applicable parts of 2 CFR Parts 300 through 5899. If Contractor or a person or entity with whom Contractor enters into a covered transaction is excluded or debarred, Contractor shall immediately notify the City in writing.

31. Entirety.

This Agreement and exhibits attached hereto and incorporated herein by this reference represent the entire Agreement between the City and Contractor. Any prior written or oral statement or proposal or representation, not incorporated herein, shall be excluded, and shall not alter any term or provision of this Agreement. This Agreement may be modified or amended only in writing by any authorized representatives of Contractor and the City.

32. Attorney's Fees.

In the event of any litigation regarding the rights and obligations of the parties under this Agreement, the prevailing party shall recover its costs and attorney's fees, including such costs and attorney's fees for appeals.

33. Applicable Law; Venue.

The venue for any legal action arising from this contract shall be Mason County, Washington, and that this contract shall be governed, construed, and interpreted according to the laws of the State of Washington.

34. Assignment and Subcontract.

Contractor shall not assign or subcontract any portion of the service contemplated by this contract without the written consent of the City. Upon seeking consent to an assignment or subcontract, Contractor shall furnish written proof that the subcontractor/assignee consents to be bound by all the terms of this Agreement, including but not limited to indemnity obligations and insurance coverage.
