Pool slots will be 90 minutes long and signups will be available one (1) day prior. Members will be limited the number of slots they can sign up for in one (1) week. An email will be sent through ©Omnify, Inc. to each family member with information on how to login and signup for a pool slot. If a family member does not have their own email, another family member in the household can sign them up for pool slots. Only registered email accounts will receive email confirmations.

Terms and Conditions: By registering for a Vergennes Sam Fishman's Municipal Pool's Pass, I understand that the payment of this fee entitles me and members of my household, as listed during registration, to admission to the Municipal Pool, provided we sign up for a time slot in advance and abide by the rules and regulations. I hereby release the City of Vergennes, its employees and agents from any liability or personal property, which my child or I may experience from the use of the Municipal Pool. I hereby consent to any medical procedures deemed advisable for my child/myself in the event I am not conscious or cannot be reached and I or my child has sustained an injury. I understand that the Vergennes Sam Fishman's Municipal Pool's rules and regulations are a part of this agreement. Members agree to comply at all times with such rules and regulations. Members who do not comply will be asked to leave immediately and can be subject to having their pool pass revoked for the season.

Vergennes Sam Fishman's Municipal Pool Rules and Regulations

1. Social Distance
 - a. All customers and employees (individuals) must stay 6 feet apart at all times;
 - i. Including within the pool and on the pool decking;
 - b. Only one individual is permitted in the bathroom at a time;
 - i. Exception: Parent helping a child in the bathroom;
 - c. Ten (10) feet diameter social distancing circles that are six (6) feet apart have been drawn on the pool deck. Customers who occupy the pool decking shall reside within a social distancing circle.
 - i. Only one household shall occupy a social distancing circle.
2. Social Distancing Exceptions:
 - a. Individuals who are family members and live together are not required to stay 6 feet apart.
3. Occupancy:
 - a. No more than twenty-five (25) individuals shall occupy the pool area at any given time.
4. Registration:
 - a. Customers must purchase a season pass to obtain a registration;
 - b. Once registered, customers shall be able to select time slots via Omnify;
 - c. Time slots for the subsequent day will be accessible up until 4PM on the day prior;
 - d. Pool staff shall pickup or be provided the registration list for the subsequent day by 4:30PM on the day prior;
 - e. Pool staff shall ensure that each customer who enters the pool is on the registration list for the time slot they have arrived to occupy;
 - f. Customers may be restricted to register for time slots based on number of pool passes sold and the activeness of the pool pass users
5. Changing rooms:
 - a. Changing rooms will be closed;
 - b. The use of the changing room area is for bathroom use only;
 - c. An outdoor shower will be installed for swimmers to rinse prior to and after use of pool.
6. Washing hands:
 - a. All individuals are required to wash their hands with soap and water when entering and subsequently occupying the pool area.
7. Sick
 - a. Under no circumstances shall anyone enter the pool area who is experience cold or flu like symptoms or expresses a fever.
