VERNON COUNTY BOARD OF SUPERVISORS MINUTES April 16, 2019

County Board Chairman, Dennis Brault called the April 16, 2019 meeting of the Vernon County Board of Supervisors to order at 9:30 a.m. in the County Boardroom of the Courthouse Annex.

Invocation was by Pastor, Pete Beckstrand of Bethany, Bethel and Zion Lutheran Churches.

Board members and others present gave the Pledge of Allegiance. County Clerk Hoff affirmed there had been proper public notice of the meeting.

Motion by Servais, 2nd by Bringe to excuse Cary Joholski, Loren Goede and Adrian Amelse from today's meeting. Carried all.

County Clerk, Ron Hoff, called roll call with <u>26</u> supervisors present.

Motion by Eggen, 2nd by Leis to approve the minutes of February 5, 2019. Carried all.

Chairman Brault asked if there were any announcements;

If you need a new County badge, Serena can take your picture at break and print it by the end of meeting. WCA Annual Conference is at Kalahari Resort, Wisconsin Dells on September 22-24, 2019. If you need a room, let Ron know by May 1, as rooms fill up fast.

Proceedings book from 2018 are on your desk.

Brault asked if anyone wants June meeting in the evening at 5:00 PM. No objections so June 4, 2019 is a 5:00 pm meeting.

Larson stated the Dairy Breakfast is June 15, 2019 at Dale & Brenda Torgerson farm east of Viroqua.

Chairman Brault moved to Special Order of Business. Federal Watershed Assistance update with Ben Wojahn, Mark Erickson and Scott Mueller of NRCS. Erickson stated Jersey Valley and Mlsna Dams failed in August 28-29, 2018 flood. Mueller explained the repair process and we need to be patient. They are researching all records on the Dam back to the 1950's. They showed slides of the dam profiles and where breaches occurred. Dams not breached will receive needed repairs soon with help from EWP funds. Could be years for a decision on breached dams future. Redington asked about Hillsboro area watershed. Mueller stated this not in his area. Call asked about clean-up cost and who pays. 75% federal and 25% local, approximately \$50,000 per Dam. Henry asked about any certain zone in each Dam failing. That is still being studied. Ofte asked if concrete spill way in Jersey Valley would have saved the Dam. Yes that is very possible. Yttri asked about rainfall, it is increasing so yes Dam specific designs need to be changed to handle heavier loads. Henry stated Jersey Valley was built in 1969 so it is a newer version but still failed. In 2008 it was repaired to standards but no cement spill way. Erickson stated DNR orders state we need decision by December 31, 2023 on future of breached Dams. Henry concerned about land owners affected by Dams. Beitlich stated land owner can give input at County meetings and is welcomed. Larson stated dams breached in many places of Country that need help, not just Vernon County. So many dams are on a wait list for funding. Brault stated floods started 2007-2008 and have been very frequent since. Vernon County has twenty two Dams.

Incident Command Requirements Refresher, Brandon Larson- All Municipalities and County Officials should receive training to understand all requirements of the program of national incidents management system, this program is tied to FEMA funds. Taylor asked which class is recommended. Taking both classes is best, one class is May 29th here in Viroqua.

Revolving Loan Update, Diane McGinnis-McGinnis stated Revolving Loan started in Vernon County in 1999 for CROP. It started with Federal funds. There have been seventy two loans in County to date. It started 240 jobs in the county. HUD programs have closed all new loans as of January 31, 2019. Now approximately \$500,000 in fund, approximately 2.5 million is out in loans, term of last loan is 2037. Approximately \$11,000.00 a year is cost to oversee Vernon County program. The County can buy out the whole Portfolio and administer as County Program, or turn fund over to HUD. At the June 4, 2019 meeting the County Board will have to vote on a buyout option of the program. Approximately 1.2 million to buy out the program. Olerud stated we recently had three more loan requests, we need to keep this program for the County to help attract and keep business in the County. Taylor and Williams agree this is a logical option. Four loans have defaulted, \$162,000 since program started in 1999. Bringe stated Audit going back 20 years could be problematic, some records twenty years ago are hard to find.

Election of two members to Vernon Manor Committee for a 3-year term previously held by Eric Evenstad and Ole Yttri. Redington nominate Evenstad, Beitlich nominate Yttri. Motion by Clark, 2nd by Muller to cast unanimous ballot for Yttri and Evenstad. Carried all.

Resolution # 2019 - 3 **Title:** 2019 Ho Chunk Funds for Flood Recovery

WHEREAS, communities within Vernon County have been significantly impacted by the repetitive and historic flooding that have led to federal disaster declarations in the years of 2004, 2007, 2008, 2010 (twice), 2013, 2016, 2017 and 2018, and;

WHEREAS, due to this repetitive barrage of severe rain and flooding disasters communities are planning and implementing mitigation and recovery project, and;

WHEREAS, communities are researching state and federal grant opportunities to try to implement recovery projects, and:

WHEREAS, state and federal grants are available but require local match but local communities are depleted funds due to meeting immediate and critical needs after each event, and;

WHEREAS, NOW, THEREFORE BE IT RESOLVED, by Vernon County Board of Supervisors that \$40,000 per community below, not to exceed a total of \$360,000, of the 2019 Ho Chunk funds be made available equally to the communities of Genoa, De Soto, Coon Valley, Chaseburg, Hillsboro, Ontario, La Farge, Viola and Readstown to match grants or invest and accelerate recovery for all citizens within Vernon County.

Chad Larson – Readstown – 11 houses wiped out, Cheryl Purvis – La Farge – Substation damaged needs to be relocated. They all discussed Village damage. Terri Taylor Ontario, Need land to relocate homes and business. Adam Sonntag, Hillsboro – Need bridge, streets and barrier. Eggen asked about townships getting funding also. Ofte stated Finance Committee studied all scenarios but felt these communities needed fast Financial help to apply for grants.

Redington feels we should wait on this Resolution and help all communities at one time. Yttri stated on April 25, 2019 is the Towns Association meeting here, this should be brought up there. Resolution # 2019 – 6

Title: 2019 Budget – Additional Funds to Cover State Mental Health Institution Costs

WHEREAS, the 2019 Department of Human Services budget proposal for state mental health institute costs was prepared using prior years' data and ultimately the County Board authorized \$75,000 levy for that line item, and

WHEREAS, expenditures for costs at state mental health institutions for the month of January 2019 totaled \$75,728.63 (101% of the budgeted line item), and

WHEREAS, these costs are completely unpredictable due to the nature of human behavior along with the fluctuation of facility costs from year to year and local hospital diversion due to staffing or other barriers; and

WHEREAS, the safety of mentally ill persons and the community sometimes necessitates lengthy placements in safe and secure facilities where they receive appropriate treatment, and

WHEREAS, expenses for state mental health institutions are deducted from the Department's monthly payment from the state to provide other services. To meet the needs of individuals and avoid disruption to services, additional funds are needed for this line item; and

WHEREAS, based on expenditures to-date and general projections of costs to be incurred, the line item budget for state mental health institutes for 2019 requires an additional \$180,000.

NOW THEREFORE BE IT RESOLVED that the Vernon County Board of Supervisors authorizes an additional \$180,000 in levy into the Human Services 2019 budget line item for state mental health institution costs.

BE IT FURTHER RESOLVED that any funds that remain in this line item after expenses are paid will be returned to the General Fund.

Redington stated State keeps money first, before we receive State funds. This \$180,000 would be from the General fund. Yttri stated Human Services has extra money in other line items. Leis asked should we wait till later in the year to take this from the General Fund. Motion by Leis, 2nd by Olerud to allow Eitland to exceed budget in State Mental Health line item for 2019 and review later in year. Strudthoff concerned about waiting, prefers to pass resolution now to keep budget on line, Redington and Taylor agree. Ofte and Larson support the motion to amend. Clark called question, 2nd by Ofte. Carried voice. No 13 Yes 11. Rae, Ofte, Olerud, Larson, Running, Henry, Call, Leis, Clark, Yttri, Mitchell. Voted yes.

Motion by Brault, 2nd by Redington for resolution with amendment for \$180,000 from General Fund. Yes <u>23</u> No 1, Leis. Carried.
