**RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE
BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND
CERTIFYING THEM TO THE COUNTY AUDITOR**

WHEREAS, Council for the Village of Lincoln Heights, Hamilton County, Ohio, previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2020; and

WHEREAS, The Budget Commission of Hamilton County, Ohio, has certified its action thereon to Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by Council and what part thereof is without, and what part within the ten mill limitation.

NOW, THEREFORE, BE IT RESOLVED, by the Council for the Village of Lincoln Heights, Hamilton County, Ohio, that:


SECTION I. Council for the Village of Lincoln Heights, Hamilton County, Ohio, hereby accepts the amounts and rates as determined by the Budget Commission in its certification.

SECTION II. There be and is hereby levied on the tax duplicate of the Village that rate of each tax necessary to be levied within and without the ten mill limitation as indicated on the Auditor's letter dated August 9, 2019.

SECTION III. The Clerk of Council is hereby directed to certify a copy of this Resolution to the County Auditor of Hamilton County.

SECTION IV. This Resolution is hereby declared to be an emergency measure necessary for the health, safety and general welfare of the Village of Lincoln Heights. The reason for said emergency is the need to accept the amounts and rates of estimated property tax approved by the Budget Commission and to certify the same to the Hamilton County Auditor on or before October 21, 2019.
