**RESOLUTION AUTHORIZING THE MANAGER TO ENTER INTO AN AGREEMENT  
WITH RUMPKE FOR SOLID WASTE COLLECTION SERVICES**

**WHEREAS,** The Village of Lincoln Heights, Hamilton County, Ohio previously entered into a contract with Rumpke of Ohio, Inc. ("Rumpke") for solid waste collection services dated January 2, 2007 ("Contract");

**WHEREAS,** The Contract was extended and modified pursuant to that certain Addendum to Contract dated January 12, 2012 and that certain Addendum & Amendment to Contract dated December 27, 2016;


**WHEREAS,** Council for the Village of Lincoln Heights, Hamilton County, Ohio deems it to be in the best interest of the residents of the Village to extend the Contract, as amended, for three years effective January 1, 2020.

**NOW, THEREFORE, BE IT RESOLVED** by the Council for the Village of Lincoln Heights, Hamilton County, Ohio, that:

**SECTION I** The Village Manager is hereby authorized to execute an Addendum & Amendment whereby the Contract with Rumpke will be extended for an additional three year term at the rates specified in the Addendum & Amendment attached hereto as **Exhibit A**, beginning January 1, 2020 and continuing through December 31, 2022.

**SECTION II** This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of the Village. The reason for said emergency is the need to provide solid waste collection services to the residents of the Village without interruption.
