**RESOLUTION FOR THE APPROVAL OF PURCHASES REGARDING THE 2020 PARADE
FOR GRADUATING HIGH SCHOOL SENIORS RESIDING IN LINCOLN HEIGHTS**

WHEREAS, the Village of Lincoln Heights is hosting a parade for the graduating high school seniors residing in Lincoln Heights;

WHEREAS, the Village of Lincoln Heights has committed to purchase T-shirts and Kente cloth graduation stoles for the graduating high school seniors residing in Lincoln Heights to wear during the parade;

WHEREAS, Council for the Village of Lincoln Heights previously appropriated money into the General Fund, Recreational Department, which are sufficient to cover the cost of purchasing the T-shirts and stoles.

NOW, THEREFORE, BE IT RESOLVED, by the Council for the Village of Lincoln Heights, Hamilton County, Ohio that:

SECTION I Village Council hereby approves and authorizes the use of money previously appropriated to the General Fund, Recreation Department, for the purchase of T-shirts and stoles in the amounts as indicated below:

SECTION III This Resolution is hereby declared to be an emergency measure necessary for the health, safety and general welfare of the Village of Lincoln Heights. Specifically, the t-shirts and Kente cloth graduation stoles need to be ordered immediately so that they arrive in time for the parade.
