Description of Treatment Process and Collection System:

Wastewater Treatment Plant- 3.65 MGD WWTP consisting of influent metering, mechanical bar screens, automatic aerated grit chamber, splitter box, aeration basin, 2 activated sludge oxidation ditches, four secondary clarifiers with scum removal and pumped return sludge, five tertiary deep bed denitrification sand filters with methanol storage and feed system, dual parallel chlorine contact chambers with flow paced liquid sodium hypochlorite feed, sodium bisulfite dechlorination system, post aeration, lime storage tower and dual lime injection vaults, caustic soda and alum feed system, four concrete sludge thickening lagoons, sludge recirculation pump station, effluent pump station, discharge into Tar River and water reuse system.

Collection System-Collection system consists of 74.30 miles of gravity sewer mains from 6" to 24" in diameter and 27.0 miles of force mains with 4956 service connections.

II. Performance

Permit Violations / Environmental Regulations

1. October 10, 2015 - An estimated 200 gallons of wastewater spilled into a storm drain at West 9th and Washington Street intersection. The spill was due to grease and paper in the main line. No known environmental impacts occurred as a result of this spill.

III. Notification

Wastewater Collection Report

During 2015 the Wastewater Collection Division responded to the following complaint calls;

126 Sewer tap stoppages
3 Mainline stoppages
128 Customer sewer complaint calls
257 Total sewer complaint calls

The City of Washington Wastewater Collection Division provides routine sewer maintenance. We routinely clean sewers as a preventive step to reduce the number of stoppages. In 2015 we performed routine maintenance on 125 sewer taps. We cleaned and flushed a total of 11.56 miles of sewer mains and installed 15 cleanouts on taps.

The Wastewater Collection Division made 47 repairs to the sewer system in 2015. These repairs range from cleanouts to mainline repairs.

The Wastewater Collection Division mowed and inspected the outfall line right of ways twice during 2015. The outfall line was also sprayed by a contract spray company in 2015. The Division also inspected all high priority lines monthly during 2015.
