II. Submission/Approval of Meeting Minutes

III. Reports from the Officers

a. Treasurer's Report There was a deposit of \$35,762 on February 4, 2021. We paid 2 invoices to Eastman & Smith for a total of \$12,175.00. Our balance is \$26,004.53. A check was written to Philadelphia Insurance for \$1362.00 but has not cleared as of the meeting. There is a discrepancy with the bank on the

Eastman & Smith check in the amount of \$8,537.50. The bank only deposited \$8537.00 leaving a \$.50 difference. Mr. Watrol has a call into the bank to have this rectified. There is an outstanding invoice for Eastman & Smith for \$2,200.00

b. Trustee's Report
 As of February 16, 2021 all accounts have been closed.

IV. Old Business

- a. Project Updates Mr. Huffman gave an update on the Diemling Rd/Lime City Rd project and how the funding is being spent. Wood County Port Authority – Mr. Williamson reported on the 795-corridor study, there is potential for grant dollars for transportation improvement projects. Diemling / Lime City Road grant agreement with EDA is coming. Commissioners committed \$250,000 to the project.
- b. Philadelphia Insurance vs. CORSA Mr. Williamson spoke with Stapleton insurance, the carrier for the County Risk Sharing Authority about coverage for the TID. At this point the deductible of \$100,000 outweighs the risks. Current deductible is \$5,000. The board gave Mr. Williamson leverage to continue discussions with Stapleton Insurance.

V. Public Forum

- a. Wood County Port Authority Mr. Huffman gave an update on some projects they were finishing up and a few that are getting started.
- b. Bowling Green Economic Development Ms. Thompson gave an update on the Woodbridge park expansion. They are interested in applying for TID funding for this project in the future.

VI. New Business

a. Hinkle Report 2019 – the State Auditor's last financial report was in 2018 which was completed by Don King. He is willing to provide the TID financial reports for 2019 & 2020. The cost to develop these reports will be \$1900/per year.
Mr. Watrol made motion to hire King & Associates. Mr. Rywalski seconded.
